I read the instructions, and understood that with this grant we cannot support PhD students. However, it does not specify whether with this grant we can pay Masters, Undergrads or Postdocs. Could you please clarify if we can pay/support Undergrads, Masters and or Postodocs?

PhD and Post- Doc students can be part of the research team- the GCBC cannot fund a PhD, but if elements of the research will be undertaken by students (both pre and post doc) working in project team, then the associated research costs including stipends would be eligible, however not permitted for funding includes the cost of their studies(e.g., Tuition fee).

As I understand it, the overhead rate is 15%, as noted in the FAQ document. and Budget Could you confirm if this is calculated as 15% of the total project costs? i.e. for a grant that was requesting £100,000 in costs, we could ask for £15,000 in overheads? Could I also check if this same overhead rate applies to both Lead and partners?

15% is the overall overheads are against the total budget including lead and sub-grantees i.e., whole consortium. As long you meet the 15% limit of total budget, we have no specific requirements how this is achieved across consortium.

What are the policies regarding allowable overheads/indirect costs? Commercial Application and Budget

Co-funding is acceptable and indirect costs needs to proporationate in ratio of cofunding, but there needs to be a clear separation between the activities that are funded by GCBC and any co-funded activities. This is to ensure that it is clear how GCBC funds are being utilised and that they are not being used to support activities that are out with the agreed project proposal, furthermore if you have any further queries, please let us know.
